Member Release of Liability and Indemnity Agreement

with

Peppy Paws Pooch Park, LLC

Applicant has reviewed the Member Handbook with staff of Peppy Paws Pooch Park and understands and agrees that:

- While member dogs' vaccinations, license, leash, and proper collar are all initially checked and it is asked that only healthy dogs visit the park, this is not a guarantee that at any given time a dog will be compliant and therefore there is still some risk of disease transmission and/or injury.
- Only neutered male dogs, female dogs who are not in heat, and dogs at least four months old are permitted in the park, but there is a risk that a dog could be in the park in violation of those rules.
- All dogs must be leashed when outside the fence and are not permitted on neighboring mowed lawns.
- The fence is not guaranteed to be dog-proof.
- Choke, prong, or spiked collars are not permitted in the park because of the potential for injury to dogs (wearer or other) or people.
- Only bite-sized dog treats are allowed in the park. Non-alcoholic beverages in non-glass containers only.
- Any incidents in violation of this agreement and the Member's Handbook shall be reported to park staff.
- The golden rule of the park is that you defer to others' requests.

init _____ Successful completion of a temperament evaluation does not guarantee that a dog will not in the future exhibit aggression towards other dogs or people. At best, such an evaluation will eliminate only the very obviously unsuitable dogs. According to the Ohio Revised Code, dog owners are legally responsible for any injuries or damage caused by their dog.

init _____ No children 12 or under are permitted in either the large or small dog parks and they must be supervised at all times if in the Commons Area (dog-free zone). Children over age 12 must have written parental consent to enter the dog parks. All children must be instructed on proper behavior in the presence of dogs. Parents are responsible for the actions of their children.

init _____ Dogs are not permitted to be aggressive. If my dog exhibits serious aggression I will leave the park immediately. If another dog exhibits serious aggression, I will politely voice my concerns to the owner and if they do not remove their dog, then I will leave the park to avoid possible conflict and privately report the incident to park staff.

init _____ I will clean up after my dog and remind others to do the same with their dogs. This is to minimize the possibility of parasite and disease transmission. It cannot completely eliminate it, however.

init _____ The ground at the park should be considered rugged and uneven and contains holes, tree roots, stumps, branches, poison ivy, thorns, water, and other natural hazards including, but not limited to the risk of falling branches or trees.

init _____ If membership is revoked because of refusal to comply with park rules, no refund will be given.

init _____ If I decide to quit membership with the park, a prorated refund is at the discretion of park staff.

init _____ If the park is no longer able to provide a substantial amount of services, a prorated refund will be given.
